12.2.8 Minimization Policies Extended to Suppliers

SLU'S WASTE REDUCTION AND RECYCLING POLICY

1. Implement sustainable resource management practices, based on the Reduce, Reuse, and Recycle principles.
2. Minimize the adverse environmental effects of the transport and disposal of university assets.
3. Promote sustainable resource management practices in the procurement of goods and services.

The university's minimization policies extend to its suppliers, as outlined not only in memos but also in the written contracts suppliers must sign. These contracts specify the expectations and commitments regarding sustainable practices in the supply chain. This approach ensures that suppliers actively support the university's efforts to minimize waste and promote eco-friendly practices.

The **LESSOR** hereby leases unto the **LESSEE**, and the latter hereby accepts in lease from the former, a 46-sq.m. portion of the premises known as the **DIEGO SILANG BUILDING CANTEEN** (hereinafter referred to as "**CAFÉ LUIS**"), located at the main campus of Saint Louis University along A. Bonifacio St., Baguio City, under the following terms and conditions:

ITEM 1. Commencement of lease shall be on **01 AUGUST 2024** and shall be terminated on **31 JULY 2025**. However, failure of the **LESSEE** to comply with any provision of this Contract shall automatically terminate this Contract of Lease;

ITEM 2. The term of the lease shall be for the stated period in Item 1. The renewal of the Contract is subject to the evaluation of **LESSEE'S** compliance by the **LESSOR**. The **LESSOR** shall therefore have the prerogative of whether or not to renew the lease. However, either Party may terminate and cancel this Contract of Lease at their option by furnishing the other Party a written notice at least sixty (60) days prior to the date of the intended termination.

The university's policy on minimizing disposable items extends to all outsourced services and supply chains, ensuring that sustainability principles are consistently upheld beyond campus operations. To promote accountability, these external partners will be evaluated by internal clients, students, and employees through annual assessments to verify compliance with waste reduction and sustainability guidelines. Through these comprehensive measures, Saint Louis University (SLU) continues to demonstrate its strong commitment to environmental stewardship, responsible resource management, and continuous enhancement of its waste reduction initiatives.
